With reference to the 1st letter cited, Applicant has requested to the approval of SIDCO Industrial layout for the Villupuram District– Kandachipuram Taluk – Mugaiyur Panchayat Union - Nayanur Panchayat and Village S.F.No.124/1– Extent 29.44 Acre (119150.00 Sq.m) forwarded to District Town and Country Planning, Villupuram District for concurrence.

In continuation, with reference to the 3th cited, It is ordered that “SIDCO to retain the spaces set apart for roads, etc.-, and maintain the same for the purposes for which these space have been reserved in the approved layout to the satisfaction of the Authority and not to sell such spaces for industrial development or any other purpose. The roads in the layout must be open to the Public for access and should open in the adjoining lands to ensure access to the lands surrounding the industrial layout”, Hence, this SIDCO Industrial layout has been approved with the following conditions.

- 1) As per the condition, the layout has been approved and approved number issued as L.P/A.D.T.C.P (VD) No: 181/2026. And enclosed with 5 set of original maps and gift deeded documents has been forwarded with it for further action.
- 2) Further, when the final approval is given by the Concern local body, it is requested to send a copy of the conditions to this office immediately.
- 3) After the approval of the Concern local body. It is requested to send the approved SIDCO Industrial layout map to the concerned Registration department office and land survey department for information and appropriate action
- 4) It is requested to send acknowledgment of receipt of receiving Maps and Proceeding orders.

**Special Conditions**

- 1) With reference to the 7th cited and 8th cited letter, the concern local body must issue the final approval order.
- 2) According to the Circular No. 12544/14 /Spl.cell dated: 04.07.2014 stating that, The Directorate of Town and Country Planning Department has not legally certified the title to the ownership by granting technical clearance and planning permission. Only the Applicants entitlement to development is verified in the documents submitted with the Applicants application (lease deed, sale deed, gift deed, etc, any person wishing to purchase the property must individually assert ownership of the property to the Applicant Also, if anyone else dispute arises individual rights over it, they can settle it before the appropriate competent court. The Directorate of Town and Country Planning Department is not the right organization to decide this.

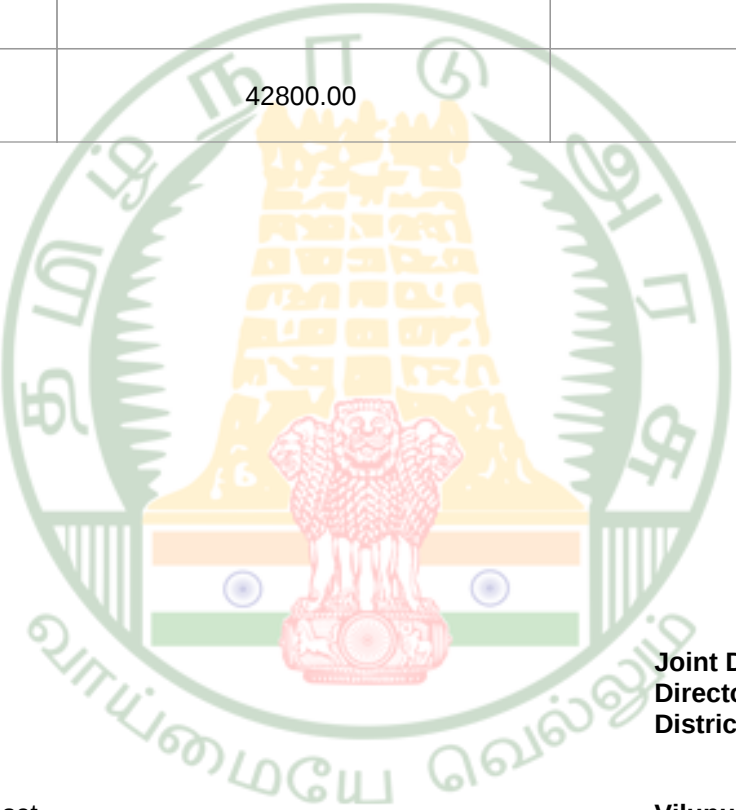
