And under rule 9 concerned local body should collect the 3% Market Land Value as Land conversation charges, before issuing the final approval

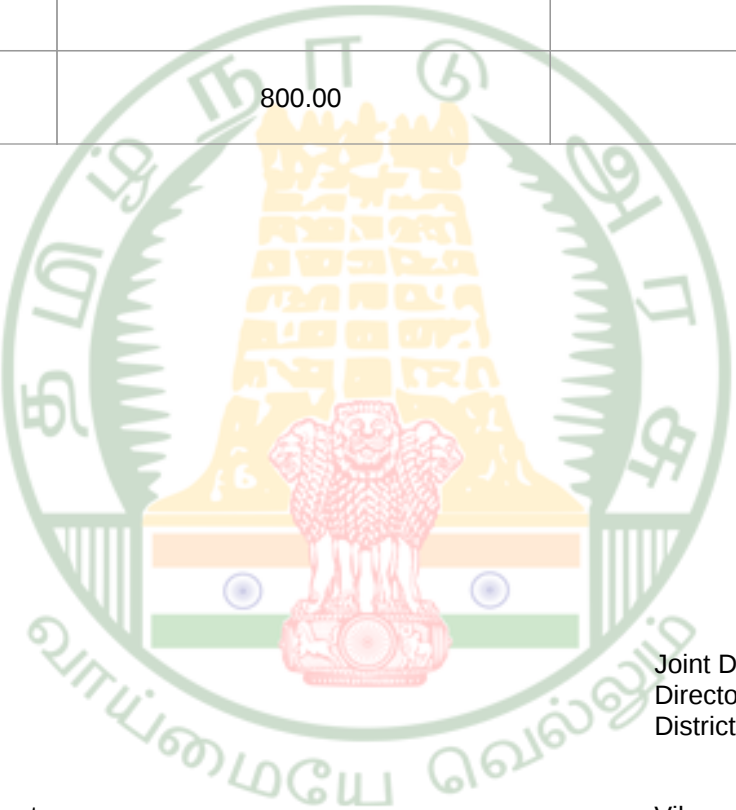
