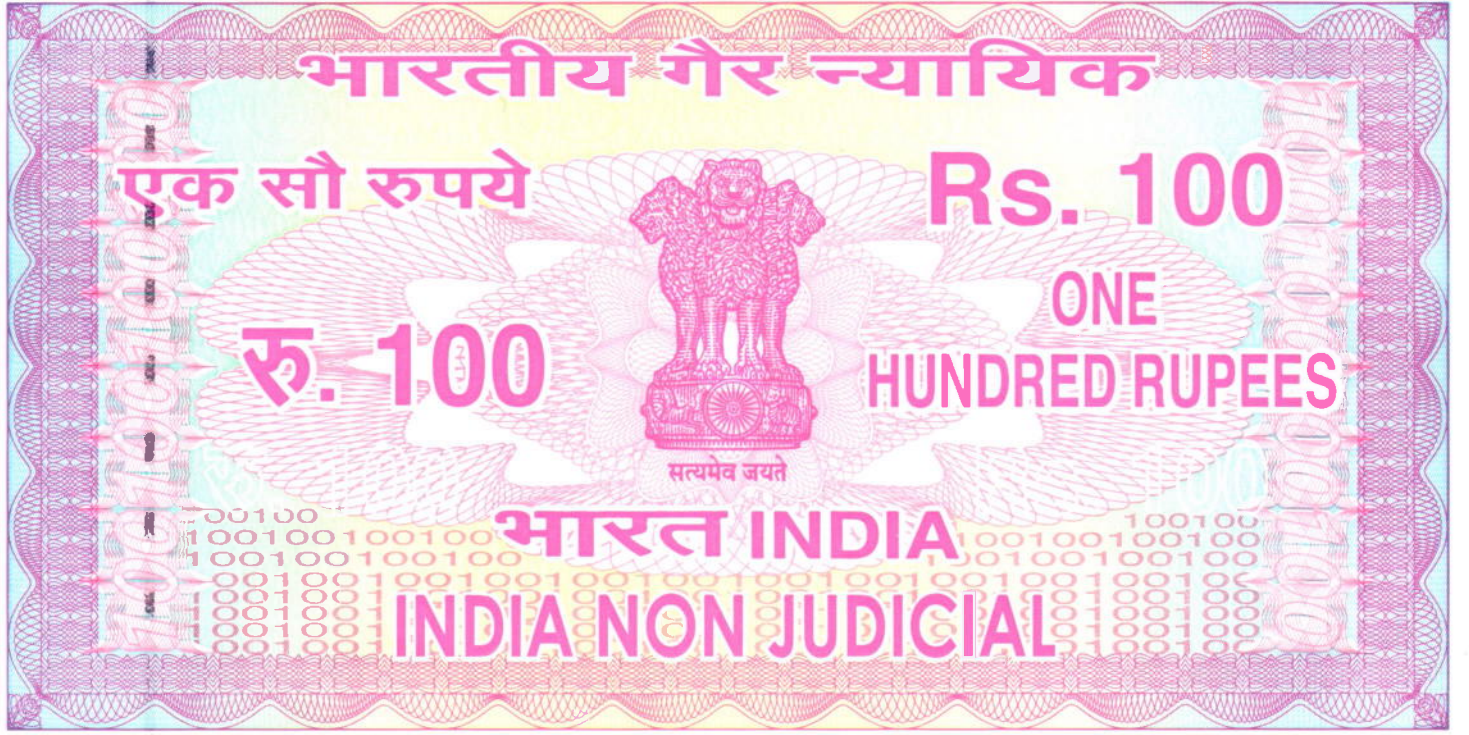

- 6 That i shall get the account audited with in six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant to the Authority and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawals have been made in compliance with the proportion to the percentage of completion of the project.
- 7 That i shall take all the pending approvals on time, from the competent authorities.
- 8 That i has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 9 That i shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
